Quidel Ortho offers a full line of in vitro diagnostic products, including blood tests for infectious diseases, heart disease and cancer.

The company focuses on developing innovative products to improve healthcare and quality of life for patients around the world. It works closely with laboratories, hospitals, clinics and other healthcare professionals to provide accurate and reliable diagnostic solutions.

The issues at the heart of a new organization

The first challenge for this international group after its acquisition was to integrate its processes into a new organization, while increasing growth and productivity. Among its daily issues, that of transport is particularly important, even critical in terms of its area of expertise and the expectations of its customers.

To meet this need, Quidel Ortho launched a call for tenders for the implementation of a transport management system (TMS) with a high level of automation. The challenge was then to maintain the quality of specialized carriers and to handle complaints in the event of damaged packages with great rigor.

• Product specificities

• Special conditions during transport, particularly in terms of temperature and humidity

Regulated information is provided in advance, with "track and trace" monitoring and proactive management in the event of delays. Traceability is thus ensured and all data is centralized.

The TMS also makes it possible to manage all carriers with a global and precise vision of the activity.

The number of complaints has decreased significantly for the 15 carriers operated by the solution, from the largest players to the smallest companies. This, thanks to the quality of the information which facilitates the monitoring of carriers, and the management of claims in the event of damaged packages.

The simplified and auto-completed input screen also offers optimal use of the solution and therefore promotes real adoption by teams.
